

COMMUNITY-BASED TOURISM POLICY IMPLEMENTATION STRATEGY OF THE BONO TOURISM AREA IN PELALAWAN REGENCY, RIAU PROVINCE

Abstract

The focus of this research was the Community-based Tourism Policy Implementation Strategy of the Bono Tourism Area in Pelalawan Regency Riau Province. This research aims to explain and analyze the effectiveness and the factors that influence the effectiveness of the Community-based Tourism Policy Implementation Strategy of Bono Tourism Area. Furthermore, this research used qualitative method with data collection techniques in the form of observation, in-depth interviews and literature study with the theory used was Grindle's theory (1980), and for CBT with Suansri's theory (2003). The results have shown that the policy implementation Strategy CBT for Bono Tourism Area in Pelalawan Riau Province is in accordance with the research focus related to Policy Content, Policy Context and CBT Principles as one of the factors to describe the effectiveness of Policy Implementation Strategy CBT in developing the Bono Tourism Area for improving the economy and welfare of local communities. Furthermore, the novelty of the recent research divided into each dimension. They are Communication in Policy Content, Responsibility and Rights in Policy context and Cultural Principle in CBT Principle. In order to run Policy Implementation Strategies effectively. Maintaining the Local Cultural Uniqueness indicator is significant.

Deep strategy development based tourism community like Pokdarwis This is a development strategy tourism that delivers role dominant to public as well as community For manage development tourism, esp in control nor manage source Power productive, so expected development area tour Can walk with maximum in accordance with hope.

CBT is used as one of the form paradigm new development tourism that carries principles development sustainable (*sustainable development*) for the sake of achievement prosperous society (Sasongko et al., 2020). According to writer, development tourism uses role as well as

Meanwhile, Bono is wave river located in the District Teluk Meranti, precisely at the Muara (Kuala) Kampar River in the Regency Pelalawan and at the Estuary (Kuala) of the Rokan River in Rokan Hilir Regency. In study environment Mechanics Fluid (Environmental Fluid Mechanics), Bono called Tidal or bore/eagir/eager/eygre. By scientific The Bono Wave is meeting tidal currents with current river from Upstream towards estuary (Downstream). Sea water flow come in and meet with the water of the Kampar River so happen wave with sufficient speed high, so produce voice like voice thunder and sound wind tight. During the high tide season (usually happen when season rain, that is around November and December) the water flow of the Kampar River is sufficient big. In Plan Strategic District Regional Apparatus Pelalawan Riau Province is included in Regulation Regent Regency Pelalawan Number 60 of 2021 concerning Procedures for Distribution and Determination Details of Village Funds for Each Regency Village Pelalawan Rahun Budget 2021 (next called Regional Regulation Regency Pelalawan No.16 of 2021). In Article 9 numbers roman XVII set that the Department of Tourism, Youth and Sports (hereinafter called Disparpora) is one of them device areas in the Regency Pelalawan handles it or manage related things with tourism, youth and sports in the Regency Pelalawan. Related with development tourism and development area tourism in the Regency Pelalawan, Disparpora has create a work program based on mission Regency Pelalawan, one of them is develop tourist area based participation society and culture Malay as glue of the country (Advanced Tourism and Culture), through Several programs include improvement programs Power pull destination tourism, management program area strategic tourist districts and marketing programs tour.

Some of these programs implemented with stage exhibitions and promotions tourism, increase development application nor information tourism Regency Pelalawan, held *events* tour Sailboats and Jungkatel, Bekudo Bono Festival which is form support implementation *events* tourism, culture, youth and sports by Disparpora. Apart from that, it is also done development nor enhancement to means infrastructure tourism, procurement equipment means maintenance activity tourism, as well as build infrastructure his supporters as well as give donation A *Jetsky* to Pokdarwis.

Pokdarwis in the Bono Tourism Area was formed based on Regent's Decree Number: KPTS.821/DPPO/2021/941 and made as umbrella law for Disparpora implement their program in develop tourist area based participation deep society study This called as CBT. Bono Tourism Area programs expected synergize with enhancement wisdom culture local in the end can impact to enhancement economy public as part from development tourist.

When the author do pre-survey to location study there is data that since In 2015 there were a number of stages that have been done done Disparpora in implementation of work programs Field Tourist . Implementation of work programs the started with exists implementation development facilities and infrastructure in the Bono Tourism Area, but Still Lots found lack like development yet 100% complete or not optimal, in fact something collapsed like seen from table as following:

Then operational parameters in study This refer to 6 Content Policy (Ohoira et al., 2023) namely: Interested Affected (interests that influence programs/policies); Type of Benefits (type the benefits will be generated); Extent of Change Envisioned (level desired changes); Site of Decision Making (position maker decision); Program Implementor (who program implementer); Resources Committed (source Power committed); 3 Context Policy from Grindle (Syafrizal & Marto, 2021) namely: Power, interests, and strategies of actors involved (power, interests and strategies of the actors involved); Institution and regime characteristics; (character institutions and regimes); Compliance and responsiveness (compliance and power responsive); and 5 Principles of CBT by Suansri (Musleh, 2023) namely: principles economics, principles social, principles culture, principles environment and principles politics.

Data collection techniques use procedures deep data collection study involving qualitative four type of strategy that is observations, interviews, documents and audio and visual material. More Next, technique data analysis was carried out with interactive and taking place in a way continuously in the form of data *reduction* (summarizing), data *display* (presentation) and *conclusion drawing verification* (drawing). conclusion and verification).
